## 1.0 PURPOSE

1.1 As a minimum, U.S. Custom and Border Protection regulations require all imported parts to be marked with Country of Origin (for example, "Made in Japan", or equivalent country) on the display carton. This requirement is applicable to all Finished Goods/Components packaged in individual boxes. With respect to bulk or raw materials, the outer container is required to be marked accordingly. Any intentional removal, defacement, destruction, or alteration of a marking to conceal this information may result in potential fines and/or penalties.

## 2.0 SCOPE

2.1 To provide working instruction to all suppliers on labeling requirements per U.S. Customs and Border Protection (CBP) Regulations 19 CFR Part 102, 134 and 181.

## 3.0 POLICY/GUIDELINE

3.1 Labeling is required on all products imported by Haldex. The labeling requirements are listed below:

- a. Outer containers of Bulk Shipments shall be permanently marked by means of stenciling. Photocopied sheets taped to the outer container are not an acceptable form of marking.
- b. Display cartons of individual salable units will be permanently marked. It is not recommended to apply adhesive labels as they tend to fall off the product while in transit.
- c. Permanent print shall be the same font and font size as other print on the display cartons.

3.2 Documentation for all shipments imported by Haldex shall include the country of origin information. Documents are as follows:

- a. Commercial Invoice
- b. Packing List
- c. Manufacturer's Affidavit
- d. Testing report (when applicable)
